Peace on Earth

The path to peace in the world, our families and our hearts begins with conformity to the virtues of Christ

ON THE FIRST Christmas night, the sky was lit with stars but shone brighter than ever with God's glory. Born that night was Jesus, "the light of the world" (Jn 8:12) and "the true light which enlightens everyone" (Jn 1:9). Filling this resplendent scene with song were the angels who proclaimed, "Glory to God in the highest and on earth peace to those on whom his favor rests" (Lk 2:14) — words we often echo at Holy Mass.

Glory to God, peace on earth, good will in human relationships: Do these words not awaken in our hearts a deep longing? After all, we live in a world that is anything but peaceful. We live in the shadow of nuclear war and terrorism. Many fellow Christians and other believers suffer religious persecution. Millions of refugees are dispossessed and driven from their homes. Many at home and abroad suffer from poverty, racism, lack of health care and economic inequality. Peace is threatened by the lack of reasoned dialogue among political leaders, nationally and internationally. Nor can we overlook the societal discord and lack of civility so painfully evident, for example, in social media.

The angels' greeting for the Prince of Peace may also strike close to home, for many families suffer from a lack of peace.

At Christmas, those things that divide our families weigh heavily on our hearts. Every family has its disagreements, but in some they harden into grudges and alienation; discordant relationships can also disrupt the workplace and other communities we belong to. Ultimately, if we want to have peace in the world, we cannot neglect the disordered state of our own hearts.

VIRTUE AND ORDER

A popular hymn begins: "Let there be peace on earth, and let it begin with me." I used to complain about those lyrics because they seemed self-centered. "Peace doesn't begin with me, but with Jesus," I mumbled as others poured their hearts into this song. Of course, that's true: Jesus is the source of our peace. Yet, as time went by, I began to understand something that the Word of God and great spiritual writers constantly teach us. When our lives are in order, the peace of Jesus reigns in us and we become sources of true peace in a divided world. When our lives are hobbled by various forms of disorder, we contribute to the world's divisions and discord.

A well-ordered life is not necessarily a tidy, predictable life, nor is it exempt from pressures and stresses. Rather, an or-

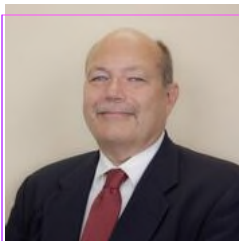

From the Vocations Director

Our diocese is made up of approximately one third Charleston diocesan priests, one third on loan from other dioceses, and one third from religious orders in the state. The largest group of religious is the Adorno Fathers with Immaculate Conception in Goose Creek, Jesus, Our Risen Savior in Spartanburg, and the combined parish of St. Anne & St. Jude in Sumter. What makes them so special is that they are growing in size. While the diocese has 23 enrolled in seminaries, the Adorno US, Philippines delegation has 34 in formation.

This year, our diocese will ordain one seminarian to the priesthood. On the Feast of Our Lady of Guadalupe, Adorno Brothers Kevin Daborbor, CRM and Rufino Madrudejos, CRM were ordained to the transitional diaconate by Bishop Guglielmone at St. Jude's parish in Sumter. The 4th degree honor guards were present from Goose Creek and Sumter, as well as Knights of Peter Claver and the Knights of the Holy Sepulchre. In June, Deacons Kevin and Rufino will be ordained to the priesthood in Goose Creek. Within 2 years, there will be another 6 Adorno Brothers in the program that will be ordained as well.

While the typical path for a diocesan seminarian takes 6-8 years, the Adorno seminarian's formation process takes longer. Typically from 10-12 years. In addition to the 4 years of college, they must do a postulant year as well as a novitiate year, 4 years of theology, then a pastoral year in a parish. Half way through their pastoral year they are ordained as a deacon, then 6 months later ordained to the priesthood. The Adorno Fathers take two additional vows that their diocesan priests do not. They take a vow of poverty and humility.

It is important for us to support the seminarians that will be

Councils and Assembly Meetings

The Grand Knight and Faithful Navigator must conduct their meetings in accordance with the Charter, Constitution and Laws of the Knights of Columbus, supplemented by your Councils or Assembly's by-laws and according to parliamentary procedure. The standard reference on the subject of procedure is Robert's Rules of Order. The order of business for conducting a Council or Assembly meeting is outlined in *The Method of Conducting Council Meetings* (#10318) and

The Method of Conducting Assembly Meetings (#10325), both available from "knightsgear.com." Presiding officers should control all meetings so that they follow the set agenda by limiting any sidebar discussion.

When a member wishes to speak, he does so by rising from his seat, addressing the chair by saying "*Worthy Grand Knight*" or "*Worthy Faithful Navigator*" and renders the salute. (Representing the tree of the Cross, the member makes a vertical motion, with his arm and vertically opened hand, from top to bottom). The presiding officer recognizes the speaker by announcing his name and rendering the salute in return. (Representing the arms of the Cross, the presiding officer makes a horizontal motion, with his arm and horizontally open hand, from left to right).

The presiding officer should at all times refer to and address the officers by their proper title. He is thus setting a good example for all members to follow.

All members who are not officers should be recognized by name as "Brother _____" or "Sir Knight _____" All questions or comments must be directed to the chair (the presiding officer), for example: "Worthy Grand Knight or Worthy Faithful Navigator may I ask the previous speaker to explain....."

The presiding officer always speaks in the third person such as "The chair rules that ..." or Your Grand Knight or Faithful Navigator reports that"

Members should speak of the chair in the third person: "Worthy Grand Knight or Worthy Faithful Navigator will the chair please explain the effect of the pending motion?"

From the State Retention Chairman

As the State Retention Chairman, I recently took the opportunity to send the State's Grand Knights, Financial Secretaries, and District Deputies an email discussing Membership as well as some thoughts on Retention. I received some encouraging replies to the email. Please allow me a few minutes to continue the discussion. As always, I appreciate and value any comments.

We know each council will review their roster every year to insure they have complete and current information at Supreme for every member of the Council. This review is routinely completed by the Financial Secretary and unfortunately does not always include updating the current information on the Council's roster. The Financial Secretary is not a mind reader, he needs every Knight to include him with all of his current contact information when appropriate. Some Councils have been proactive and include an information sheet with the dues notice, requesting the Knight return the sheet with appropriate updated information.

Once in a while the Financial Secretary may also find a Knight whose situation has changed from when they were recruited and became a knight. This information must be forwarded to the Retention Committee as soon as possible. The Retention Committee will follow up with the Knight and update the Grand Knight and Financial Secretary on their findings and recommendations. It is never appropriate to hold an open discussion on a Knight's personal information at an open Council meeting due to the potential personal nature of the information. The Council should react by following the complete retention procedure outlined in the Financial Secretary's Handbook to insure the correct decision is made regarding the Knight's future. Each Council's Retention Committee should be aware of the difference between a Withdrawal and a Suspension. When completed a Council may feel compelled to drop a Knight during the year. Please include the District Deputy in this decision. Doing this early in the Council Year will allow the Council to maintain the opportunity to still achieve all of the Supreme and State Council Awards their Council should earn each year as a result of the Great Works they accomplish.

Our State Deputy, Mike Allen, does not want to stand in the way of any council updating their roster, but he also does not expect the purge that occurred last year. Situations that seem extreme will be questioned.

If necessary, please review your Council's situation with your District Deputy for guidance. I am also available to any Council for a discussion regarding your situation. The best thing you can do is overcome your suspensions with your recruiting efforts!

Council 10819 Columbus HOPE Foundation Project



During the two weekends of October 20-21-22 and October 27-28-29, 2017 the Knights of Columbus, Council 10819 at Saint Mary Magdalene Catholic Church in Simpsonville, SC held their second Tootsie Roll Drive of 2017 at the Walmart Super Center Store on Grandview Drive in Simpsonville, SC. Thirty one Knights graciously gave their time, over the two weekends Drive, to man the two Walmart entrances/exits collecting donations for the Columbus HOPE Foundation charities in South Carolina and the Upstate area. These charities provide services that "Help Other People Everyday", which is dedicated to increasing the self-reliance and dignity of our mentally and physically challenged citizens.

Over 340 man hours were volunteered by the Council Knights in planning, collecting donations and counting funds collected after each day. Several Knights' Family members also helped with the collecting and counting activities. Large Tootsie Rolls were given to donors and their children. The Knights collected \$7,381 during the October two weekends Tootsie Roll Drive. Combining this with the \$6,576 funds collected during their first two weekends Spring of 2017 Drive, Council 10819 is proud to announce that it has raised over \$13,900 for the Columbus HOPE Foundation charities. These Tootsie Roll Drives are two of four annual Columbus HOPE Foundation fund rising projects.

derly life is a virtuous life, lived in the real world. Virtues are those firm qualities of character that help us to live in a right relationship to God, to others and to ourselves.

The three theological virtues (faith, hope and love) help us to live in a right relationship to God. The four cardinal (pivotal) virtues are stable qualities of mind and intellect that govern our appetites and actions in accord with reason and faith. They enable us to relate to others in a wholesome and generous way while respecting our own God-given dignity. These four virtues are prudence (by which we discern what is good), justice (by which we are constantly and firmly disposed to give God and others what is their due), fortitude (by which we remain firm and constant in the midst of difficulties) and temperance (by which we achieve mastery over our appetites and govern our emotions).

Those who acquire these virtues live orderly, peaceful lives and are a source of peace for others. By contrast, those who are disconnected from God and whose appetites and emotions are out of control bring havoc, loneliness and bitterness to themselves and others.

THE WORD BECAME FLESH

The theological virtues are received in baptism, the result of the grace of the Holy Spirit. We acquire the moral virtues through effort and practice while aided by grace. When these virtues take root deep in our mind and heart, we begin to live a well-ordered life — a life in which we have the interior strength to love God with our mind, heart and spirit and to love our neighbor as ourselves. Think of how different the world would be if we all opened our hearts to the theological virtues and entered into a deeper relationship with the living God. Think of how good the world would be if, in God's grace, everyone strived to attain the moral virtues and self-mastery. With this in mind, let us look at Jesus with the eyes of faith. He is God's eternal Son who assumed our humanity, and it is through his humanity that we are saved. The Son of God became man so that he could offer himself totally to the Father and to us. His gift of self is meant to shape who we are and how we live.

The Child in the manger shows us how much God must love us if he would send his Son to save us from our sins, as well as how highly God regards our humanity that his Son would become one of us. The humanity of Jesus is a model for our humanity, exemplifying the Beatitudes and every virtue.

So as Christmas approaches, let us open our hearts to Jesus, true God and true man. Let us ask him for the grace of the Holy Spirit to put our lives in order, modeled on and sharing in Christ's sacred humanity. Our conformity to his humanity is a lifelong process of growing in intimacy with Jesus through prayer, the sacraments and service to others. The closer we are drawn to Christ and the more our humanity reflects his

goodness and love, the greater will be our peace and the better equipped we will be to bring peace to a troubled world.
